Neurosoft announces Mr. Michal Houst resignation from Board of Directors and announces Mr. Petros Xarchakos appointment

Iraklio Attikis, Monday, 30 September 2019 - Neurosoft S.A. - a software house, listed on AIM Italia market (GRS802003004, Reuters NRST.MI, Bloomberg NRST:IM) for which Banca Intermobiliare SpA is Nominated Adviser — announces that Mr. Michal Houst, Executive Member of the Board of Directors of the company, has submitted today his resignation from Neurosoft's Board of Directors due to his exigent professional obligations, a position he held since June 26th, 2015. His resignation is effective as of today. The Board of Directors after today's meeting appointed Mr. Petros Xarchakos, Operational Finance Director of OPAP, as the new Executive Member of the company.

The entire Board of Directors thanked Michal Houst, who was also member of the Steering Committee for his very substantial and active involvement in the company and wishes him all the best for his future plans.

Michal Houst as of today doesn't hold any stake in the company.

The election of Mr. Petros Xarchakos will be duly announced, validated and approved by the annual shareholders' meeting of the company which will take place in June 2020.
