We do not transfer your personal information except for the reasons of the webinar. However, we may share your data with:

- Webinar platform providers and service providers assisting in hosting the webinar
- Speakers or panelists, if necessary, for event interaction
- Legal authorities, if required by law

5. Data Retention

We retain your personal information only as long as necessary to fulfill the purposes outlined in this statement unless a longer retention period is required by law.

6. Data Security

We take appropriate and reasonable security measures to protect your personal information from unauthorized access, disclosure, alteration, or destruction. We limit access to your personal information to those who have a genuine business need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality
